## TO: AAU Players and Parents for the 2017 Season

The purpose of this letter is to advise you what to expect should you be notified that you have made a team.

- You will be notified by your coach by **Monday, March 6, 2017**. You must let them know if you accept our invitation at that time.
- You will need to attend the mandatory player/parent meeting being held on **Thursday, March 9, 2017 at 7 pm** at the **Lyons Community Center (LCC) Lyons, NY**. The address is: **9 Manhattan St Lyons, NY 14489** and the phone number is: **315-946-6202**.
- At this meeting, we will answer all questions parents and players may have about our organization, as well as go over schedules, practices, player conduct, etc.
- **Note: MANDATORY – NEW PLAYERS must bring a copy of your birth certificate if you didn't bring one to the TRYOUTS and the Medical Form filled out completely to this meeting which we will be keeping.**
- You will need to practice with your team once a week from 5 pm to 7 pm or 7 pm to 9 pm at the New York Chiropractic College 2360 State Rt. 89 Seneca Falls, NY 13148 or other designated facility.
- You plan on making most or all of the tournaments we have signed up for.
- **After the meeting on March 9<sup>th</sup>**, and have answered and satisfied all of your questions, **your Membership Fee of \$650.00 will be due that night if you haven't paid online.**
- You can pay online before 3/9/17 at [www.centralwestern.org](http://www.centralwestern.org), or by check, cash or charge at the meeting. We accept Visa/MasterCard/Discover Cards Only. **PLEASE NOTE: Your child will not be able to participate in any tournaments until the Membership Fee has been paid in full on March 10<sup>th</sup>. No payment plan will be accepted.**
- You agree to take part in our fundraiser in which you are expected to raise \$225.00. The \$225.00 will need to be collected and turned in by 4/6/17. **If this money is not turned in by then, you may continue to practice but you will not be allowed to play in any more events until all money is paid in full.**
